The International Travel Benefit offers Bonitas members cover for medical emergencies when they travel outside the borders of South Africa. This policy is managed by Europ Assistance and administered by Linkham Services SA (Pty) Ltd (FSP:45396) and is underwritten by GENRIC Insurance Company Limited (FSP: 43638), an Authorised Financial Services Provider and licensed non-life insurer.



WHO DOES THIS BENEFIT COVER?

Bonitas members (excluding members on BonCap) who live in South Africa and have not spent more than six months abroad in the same year are entitled to this overseas benefit.

We pay claims for emergency medical and related expenses, to the medical services provider, while you and/or your dependant(s) are on an insured international journey.

Hospitalisation: out-patient and in-patient



Medical repatriation, evacuation and transportation



Emergency optical and dental expenses

IMPORTANT INFORMATION:

1. You must **activate your cover before you depart** from South Africa and have the insurance policy terms and conditions.
2. Your **trip must start and end in South Africa** and you must travel on a return international ticket.
3. The travel insurance does not cover travel with the intention to emigrate.
4. You must contact Europ Assistance for any Emergency Medical Expenses for **pre-authorisation** and case management of your hospital admission. If you do not obtain pre-authorisation, we will limit our liability to R5 000.

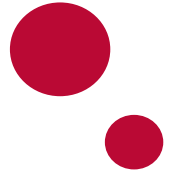
